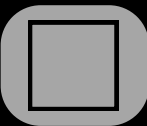

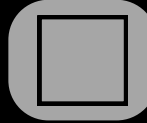
Accused of 2 Counts of Sexual Battery and Sexual Misconduct Charges while in his First Year of his Pediatric Residency Program. Cavin's had allegedly had interactions with patients during rounds on the hematology/oncology unit, during this time Cavin's had placed a patients hand in an inappropriate place on Cavin's body for four consecutive days.
Following this incident, Cavin's was allowed to see patients without anyone over seeing his duties during the remainder of his residency, due to being acquitted of these charges (Wagner Reese, 2021).

2008- Cavin's received his
medical license.
Cavin's began practicing pediatric
medicine at Witham Health Services
in Lebanon, Indiana.



According to the Court of Appeals Facts and Procedural History, Cavin's belonged to the American Academy of Pediatrics "AAP". The recommended practice to ensure and guide physicians through various stages of children. A recommendation of the AAP, is to discuss topics with adolescents (12 and older entering puberty) such as drugs, alcohol, abuse, std's, safe sex, and puberty.

2016/2017:
Cavin's began volunteering as a
coach for the Granville Wells
Elementary School basketball team
for his children.



According to Batesky Law Firm, Cavin's was married at this time and was working up until 2013 when together both parents decided that Ms. Cavin's could stay at home and be with the children due to extra curricular activities and school functions. This allowed Cavin's to work longer hours, and provide services to families who had sick children, as well as volunteer with their children's sports and other extra curricular activities within their county at that time. Giving him access to children and adolescents of all ages.

July 2018-2019
Cavin's began his abuse on one of
his first of five victims that have
come forward.



7/2018: 13 YO Child became a victim during a typical physical examination after taking victim to another room, child reported this to his mother.
Fall/2018: 16 YO Male became victim during a typical physical examination after taking victim to another room. Cavin's asked patient to fill out a depression screening form, undress & put on a gown. Cavin's asked inappropriate questions and victim pulled away. Cavin's was not wearing gloves.
12/2018: 15 YO NEW PATIENT began depression screening form, asked patient to put on gown and they began the physical exam, Cavin's made inappropriate comments, and did not wear gloves during this procedure. Child informed parent, parent believed Cavin's had no ill intentions and decided not to report the incident.

1/2019: 16 YR OLD Male became victim during a physical examination after removing patient and placing into another room. Cavin's asked patient to fill out a depression screening form, undress & put on a gown. Cavin's asked inappropriate questions, discussed inappropriate topics such as condoms and touched the victim inappropriately. The victim then "smacked" Cavin's hand away, Cavin's responded with "keep it between us". Cavin's did not wear gloves during this examination.

2/2019: 12 YO Child became a victim after a physical examination. Child denied wanting to see a condom, stating "they were not ready" Cavin's forced the patient to open this and inappropriately touching the child, Cavin's did not wear gloves.
